Sir/Madam.

I am directed to inform that an assessment to assess the physical and the other teaching facilities available for continual co-of-recognition of MPBS degree (100 sears) granted by The Tamilnadu Dr. M.G.R. Medical University. Chennal in respect of students being trained at Gove Dharmapuri Medical College, Dharmapuri was carried out by the Council's Assessors on 22rd & 2.7d May, 2018. The said assessment report was considered by the Executive Committee at its meeting held on 05.06.2018 and it was decided as undergonal.

"The Executive Committee of the Council considered the assessment report (22nd and 23nd May, 2018) and decided to recommend that recognition of MBBS degree granted by The Tamilhadu Dr. M.G.R. Medical University. Chennai in respect of students being trained in Goot. Dharmapuri Medical College, Dharmapuri be continued restricting the number of admission to 100(One Hundred) students.

The Executive Committee further decided that the attention of the institute be drawn to Sections 8(3)(2), 8(3)(3) & 8(3)(4) of the Establishment of Medical Colleges Regulations (Amendment), 2010 (Part II) dated 16th April, 2010 and act accordingly at appropriate time, which reads as under-

8 (3)

- (2) The recognition so granted to an Undergraduate Course for award of degree shall be for a maximum period of 5 years, upon which it shall have to be renewed.
- (3) The procedure for 'Renewal' of recognition shall be same as applicable for the award of ecognition.
- (4) Failure to seek timely renewal of recognition as required in sub-clause can supra shall invariably result in stoppings of admissions to the concerned Undergraduate Course of MBB. If the said institute."

The above decision of the Executar Committee has been approved by the Oversight Committee on 12.00.2018.
